

“UA Combine Competition”
Official Rules

1. GENERAL

- 1.1. Based on the country in which you have registered for and are participating in the UA Combine Competition 2023 (the “**Competition**”), the Competition is developed by UA Sports (S.E.A.) Pte. - 1.2. 1.2. In these Rules, “**we**”, “**us**” and “**our**” refer to the relevant UA Sports entity identified in paragraph 1 above and with whom you are contracting. “**You**” and “**your**” refer to any person who (as may be applicable):
- 1.2.1. is participating in the Competition;
 - 1.2.2. registered for the Competition; and/or
 - 1.2.3. is the parent or guardian of a person who is participating in and/or registered for the Competition.
- 1.3. Country-specific terms may apply at Annex A to these Rules. In the event of any conflict and/or inconsistency between the body of the terms and Annex A, the terms set out in Annex A shall prevail.

- 1.6. By registering for or participating in the Competition, you acknowledge and agree that you have read these Official Rules, and agree to be bound by, adhere to and comply with the terms of these Official Rules, as may be varied, amended or modified from time to time, and made available at: www.uacombineasia.com. To the maximum extent permitted under applicable law, We reserve the right to vary, amend or modify these Official Rules, at any time, in our sole and absolute discretion with as much notice to you as reasonably practicable.
- 1.7. If you are the parent or guardian of a person registered for or participating in the Competition, you hereby:
- 1.7.1. acknowledge and agree that you have read and understood these Official Rules;
 - 1.7.2. agree for your child / ward to participate in the Competition;
 - 1.7.3. warrant and represent that you are not aware of any illness, injury or medical condition that would prevent or interfere with your child / ward's or any other party's safe participation in the Competition;
 - 1.7.4. agree to comply with the terms of these Official Rules where applicable (including in relation to the provision of consents required under paragraph 3.1.4) and as may be

varied, amended or modified from time to time, and made available at: www.uacombineasia.com; and

- 1.7.5. agree that, to the maximum extent permitted under applicable law, we reserve the right to vary, amend or modify these Official Rules, at any time, in our sole and absolute discretion with as much notice to you as reasonably practicable.
- 1.8. To the maximum extent permitted under applicable law, we reserve the right to withdraw, discontinue, postpone or terminate the Competition with as much notice as reasonably practicable. We may also cancel or change the date and venue of the Competition with as much notice to you as reasonably practicable. We shall not be liable for any loss, damage or expenses incurred as a result.
- 1.9. If you breach (or are reasonably suspected of breaching) these Official Rules, you may be disqualified from the Competition and/or the details of your participation in the Competition may be removed from any register (publicly available or otherwise) associated with the Competition, in UA Sport's sole and absolute discretion.
- 1.10. No responsibility is assumed by us or our affiliates for any printing, typographical, mechanical or other error in these Official Rules, any online or other advertisements relating to the Competition, the announcement of any winner or prize, or otherwise in any materials related to the Competition.
- 1.11. If there is any ambiguity or inconsistency in any of the provisions in these Official Rules, UA Sports shall be the sole authority to interpret them. In the event of any inconsistency between these Official Rules and any materials relating to the Competition, these Official Rules shall prevail.

2. ELIGIBILITY

- 2.1. Subject to paragraph 2.2 below, the Competition is open to individuals who are:
 - 2.1.1. legal residents of and physically located in the country where the Competition is held (*e.g. only a resident of Malaysia can participate in the Malaysian leg of the Competition*);
 - 2.1.2. 18 years of age and older at the time of registration; and
 - 2.1.3. able and willing to comply with prevailing COVID-19 safe management requirements as may be imposed by the authorities in your jurisdiction (*e.g. vaccination requirement for large events*).
- 2.2. Persons in the following categories are not eligible to participate in the Competition:-
 - 2.2.1. employees of UA Sports or any of UA Sports' direct or indirect affiliate, parent company and/or subsidiary, members of each of their immediate family (including their spouse, parent, child, sibling, grandparent and/or "step" family) and individuals living in the same household of each such employee; and
 - 2.2.2. vendors, partners or any other individuals directly involved or connected to the Competition (including event organisers, media agencies and creative agencies), and their immediate family members.

The restriction under this paragraph 2.2 shall not apply to existing Under Armour brand ambassadors and Under Armour sponsored athletes.

- 2.3. **If you are unable to or think / observe that you are unable to safely complete any level of physical activity or perform any activity of the character required to participate in the Competition, you must not do so. You understand and agree that UA Sports may refuse to allow you to participate or continue to participate in the Competition if, in the reasonable opinion of UA Sports, it is necessary for your safety or the safety of other individuals.**

You are advised to consult your physician and/or other medical professionals to assess and determine your ability to participate in physical activities such as those required in the Competition, and you shall seek and obtain all necessary medical advice, recommendations and/or clearances prior to registering for the Competition. By participating in the Competition, you agree that you are voluntarily performing any and all activities and that only you are solely and entirely responsible for your health and well being (including mental health and well-being) in the course of your participation. You must perform all races and any associated activities in the Competition in accordance with applicable national, state, and local health precautions including any rules, restrictions, regulations and precautions in relation to the covid-19 pandemic.

3. REGISTRATION FOR THE COMPETITION

3.1. To enter and register for the Competition, you must complete **all** of the following steps:

- 3.1.1. Visit www.uacombineasia.com (the “**Website**”) to register for the Competition.
- 3.1.2. The dates, locations, and travel information for the Competition in each country will be published on the Website, you must choose the country and venue of the Competition that you are eligible for. We shall not be liable or responsible for providing transportation to the venues of the Competition and shall bear no cost or expense in relation to such transportation.
- 3.1.3. You will be required to acknowledge and sign, as part of these Official Rules, a License of Portrait Right & Release from Liability and Assumption of Risk form (the “**Release Form**”);
- 3.1.4. If you are under the requisite age of majority or contractual capacity in your country / region of residence set forth in paragraph 1.5 above, in order to register and participate in the Competition:
 - 3.1.4.1. you must obtain valid parental / guardian consent (including all necessary parental / guardian signatures to evidence such consent, including on the Release Form) to register and compete in the Competition; and
 - 3.1.4.2. your parent / guardian must agree to these Official Rules in accordance with paragraph 1.7 above, for you to register and compete in the Competition.
- 3.1.5. If you will be participating in the Competition as part of a team (see paragraphs 3.6 to 3.8 below), you must indicate as such and provide the necessary information; and

3.2. Your access to and use of the Website shall be subject to our website Terms and Conditions of use located at <https://account.underarmour.com/terms-and-conditions>, which is incorporated by reference herein and made a part of these Official Rules.

3.3. Your registration will be confirmed, valid and complete only upon:

- 3.3.1. our receipt of your payment of the Registration fee; and
- 3.3.2. issuance of a confirmation email by UA Sports.

3.4. All registrations are strictly non-transferrable. We assume no responsibility for any registration applications that are lost, mis-delivered, incorrect or incomplete. We reserve the right to refuse or reject your application to register for the Competition at anytime for any reason whatsoever, including without limitation limit on capacity or safety considerations.

- 3.5. If you wish to update your contact information or any other information submitted as part of your registration in the Competition, you may contact us at support@uacombinensea.com.

Team registration

- 3.6. You may form teams to compete in the Competition, and each team must be made up of four (4) participants competing in the same country and each participant must also register for the Competition on an individual basis as set out in paragraph 3.1 (“**Team**”).
- 3.7. If you wish to form a Team, one member of the team must indicate when prompted via email after registration, or arrive at least 1.5 hours before the first event of the day, to provide the name of the Team and the full names of each of Team members.
- 3.8. Following the Team registration, any substitution or replacement of Team member(s) will not be permitted. Subject to any exceptions that may be made at UA Sport’s sole and absolute discretion, if any member of a Team:
- 3.8.1. withdraws from the Competition;
 - 3.8.2. fails to show at the Competition; or
 - 3.8.3. is disqualified from the Competition for any reason,

the Team will automatically be disqualified. Notwithstanding the foregoing, each remaining Team member may, subject to UA’s discretion, continue to participate in the Competition in the Individual categories by converting the Team registration into individual registrations.

Deemed disqualification

- 3.9. You agree that you will not register using macro, robotic, script or other forms of automatic registration or application. Any entries in the Competition registered using macro, robotic, script or other forms of automatic registration or application will be immediately and automatically deemed disqualified, and any Registration Fee(s) paid or part thereof in connection with the foregoing will not be refunded.

Registration Fee

- 3.10. Payment of the Registration Fee shall be made in accordance with the instructions and in the manner and form as set out on the Website.
- 3.11. You shall be entitled to a refund of the Registration Fee only in the following circumstances:
- 3.11.1. if you withdraw your registration for the Competition at least one (1) week prior to the commencement of the Competition in your applicable country, you are entitled to the full refund of your Registration Fee;
 - 3.11.2. if you withdraw your registration for the Competition within one (1) week of the commencement of the Competition in the applicable country, UA Sports shall have the sole and absolute discretion to determine if you are entitled to a refund;
 - 3.11.3. if your application or registration is refused or rejected other than as a result of a breach of these Official Rules by you; and
 - 3.11.4. if you do not show at the Competition, you shall not be entitled to any refund of the Registration Fee of part thereof.
- 3.12. Where you are entitled to any refund under these Official Rules, such refund will be made in such manner as we may stipulate from time to time, subject to your provision of all relevant information and documentation as we may require to process the refund.

4. VERIFICATION OF IDENTIFICATION AND AGE

- 4.1. Upon your arrival at the Competition venue at the designated location, date and time applicable to your registration:

- 4.1.1. you will be required to check in by providing the staff located at the Competition venue with a valid and generally accepted form of photographic identification (which indicates your age and/or date of birth), such as your NRIC, FIN, driver's license, or passport in order for us to verify your identity, age and registration;
 - 4.1.2. if you are under the requisite age of majority or contractual capacity in your country / region of residence, you will also be required to provide the staff located at the Competition venue with a printed copy of the Release Form (which reflects the name and details of your parent / guardian) that is duly signed in wet-ink by the same parent / guardian; and
 - 4.1.3. you will receive a pack containing Under Armour gear which you will be required to wear during the Competition. The pack includes one (1) top, one (1) shorts, one (1) pair of socks and one (1) pair of shoes, all in the sizes specified by you during the online entry and registration process ("**Competition Pack**").
- 4.2. If you are unable to prove to the reasonable satisfaction of UA Sports and/or the staff at the Competition venue that you are a valid, registered and qualified participant in the Competition, you will be deemed ineligible to participate in the Competition.

- 5.1. The Competition's key features are as follows:
 - 5.1.1. you can compete in either the individual or Team categories:
 - 5.1.1.1. for the individual categories, the Competition is divided into men's division, women's division, or Youth division (for participants under the requisite age of majority or contractual capacity in your country / region of residence); and
 - 5.1.1.2. for the Team categories, you may compete in a mixed Team (i.e. both men, women and Youth athletes can participate in a single Team);
 - 5.1.2. in each division there are EIGHT (8) physical tests;
 - 5.1.3. you and/or your Team can choose to compete in all 8 tests or selected tests of your choosing; and
 - 5.1.4. the details for each of the tests and the relevant rules including judging criteria, injury policy and appeal process can be found at www.uacombineasia.com ("**Competition Rules**").
- 5.2. You represent and warrant to us that:
 - 5.2.1. prior to your participation in Competition and each of the tests, you have carefully read and understood the Competition Rules, and are fully aware of the potential risk of your participation in the Competition;
 - 5.2.2. you have no illness, injury or medical condition that would prevent or interfere with your or any other party's safe participation in the Competition; and
 - 5.2.3. you have not knowingly used, taken or are taking whether before or during the course of the Competition, any prohibited drugs or substances whether for performance-enhancing purposes or otherwise (including but not limited to the Banned Substance List of the World Anti-Doping Agency, which is accessible: https://www.wada-ama.org/sites/default/files/2022-01/2022list_final_en_0.pdf); and
